Application form	<ul style="list-style-type: none"><li>Completed, signed by the applicant and, if applicable, authorization of third person.</li><li>If the applicant is a minor: visa application signed twice by legal guardian and if applicable, authorization of third person. (Proving the custody of a minor child, divorce papers, dead certificate etc.).</li></ul>	<a href="#">Visa Application Form</a>
Original Passport	<ul style="list-style-type: none"><li>Issued within the last 10 years and with at least 3 months validity after the scheduled return, with at least two blank pages</li></ul>	
Passport Photocopies	<ul style="list-style-type: none"><li>Clear photocopies of the 1st page (bio data) and last page of the passport</li></ul>	
Original Old Passports (if any)	<ul style="list-style-type: none"><li>Bound together with rubber band, not stapled</li></ul>	
2 Photographs	<ul style="list-style-type: none"><li>White background, not older than 6 months (size 35 – 40 mm in width, not copied or scanned picture).</li><li>1st picture should be pasted on the application</li><li>2nd picture has to be clipped on the last page of the passport, stapled or pinned pictures cannot be accepted.</li></ul>	<a href="#">Photo Specifications</a>
Cover Letter	<ul style="list-style-type: none"><li>Original letter with day-to-day travel plan</li><li>If the applicant is submitting the applications of his/her family, then all applications must include a copy of the covering letter</li></ul>	<a href="#">Cover Letter Template</a>
Travel Insurance	<ul style="list-style-type: none"><li>Covering not less than 30,000 Euros and for the entire stay in Schengen territory</li><li>For applicants applying for a multiple visa - it is sufficient to submit an insurance policy covering the first journey</li></ul>	
Flight tickets	<ul style="list-style-type: none"><li>Onward and Return ticket both</li><li>Should include names of all travelers</li><li><b>If applicable proof of intra-Schengen flight, train itinerary or car rental</b></li></ul>	
Proof of Accommodation	<ul style="list-style-type: none"><li>Confirmation of hotel reservation</li></ul>	
Valid UK, USA, or Canada visas	If any	
If employed	<ul style="list-style-type: none"><li><b>Employer NOC:</b> Original letter on a business letterhead from the employer/company. Signed and stamped by HR or directorate mentioning applicant's position and the duration of employment, also mentioning dates and purpose of the trip</li><li><b>Last 3 months salary slips</b></li><li><b>Last 3 months salary bank account statements with bank stamp and sign on each page</b></li><li><b>Last 3 months personal bank statements with bank stamp and sign on each page</b></li><li><b>Personal ITR</b> (only ITR-V, verification form or acknowledgement) of last 2 assessment years</li></ul>	<a href="#">Employer NOC Template</a>
If Self Employed	<ul style="list-style-type: none"><li><b>Business registration proof:</b> GST Registration with annex A &amp; B, partnership deed, proof of proprietorship or other proof of ownership.</li><li><b>Last 3 months personal</b> and business bank account statements <b>with bank stamp and sign on each page</b></li><li><b>Company ITR</b> (only ITR-V, verification form or acknowledgement) of last 2 assessment years</li><li><b>Personal ITR</b> (only ITR-V, verification form or acknowledgement) of last 2 assessment years</li></ul>	
If Retired	<ul style="list-style-type: none"><li><b>Personal pension bank statement</b> of the last 3 months</li><li><b>Proof of regular income</b> generated by ownership of property or business</li></ul>	
If student	<ul style="list-style-type: none"><li><b>Personal bank statement</b> of last 3 months of parents/legal guardian/sponsor <b>with bank stamp and sign on each page</b></li><li><b>Sponsorship letter</b> providing details of financial support</li><li><b>Passport copy</b> of parents/legal guardian's passports</li></ul>	<a href="#">Sponsorship Letter Template</a>
If sponsored or unemployed	<ul style="list-style-type: none"><li><b>Personal bank statement</b> of last 3 months of the sponsor <b>with bank stamp and sign on each page</b></li><li><b>Personal ITR</b> (only ITR-V, verification form or acknowledgement) of the last 2 assessment years - if applicable</li><li><b>Sponsorship letter</b> providing details of financial support</li><li><b>Passport copy</b> of the sponsor</li></ul>	<a href="#">Sponsorship Letter Template</a>
If invited by friend/family	<ul style="list-style-type: none"><li>Invitation letter: containing full details of the inviter; full name, address, email id and telephone number</li><li>Has to be dated and signed, mentioning names of all the invitees, the duration of stay, the relationship and the purpose of the invitation, along with a copy of the passport or identity card, OCI and residential permit.</li></ul>	<a href="#">Invitation Letter Template</a>
If traveling to another country after leaving the Schengen area	<ul style="list-style-type: none"><li><b>Next country visa/travel permit</b></li><li>Not applicable if traveling back to country of own nationality</li></ul>	
If minor	<p><b>Children under 18 years old, not travelling with both parents:</b></p> <ul style="list-style-type: none"><li>Written consent letter of the other, non-travelling parent or legal guardian, certified by public notary.</li></ul> <p><b>Children under 18 years old, travelling alone:</b></p> <ul style="list-style-type: none"><li>Written consent letter of both parents or legal guardian, certified by public notary.</li></ul> <p><b>Students above 16 year old:</b></p> <ul style="list-style-type: none"><li>Copy of the student college ID card and introduction letter of the School/College/University.</li></ul> <p><i>In all cases: copies of the passports of both parents (legal guardian) or PAN cards or driving license.</i></p>	
If a visa has been refused in last 2 years	<ul style="list-style-type: none"><li>Can be any Embassy or High Commission in the last 2 years</li><li>Refusal notice or a written explanation about the reasons of refusal.</li></ul>

Original Old Passports (if any)	<ul style="list-style-type: none"><li>Bound together with rubber band, not stapled</li></ul>	
2 Photographs	<ul style="list-style-type: none"><li>White background, not older than 6 months (size 35 – 40 mm in width, not copied or scanned picture).</li><li>1st picture should be pasted on the application</li><li>2nd picture has to be clipped on the last page of the passport, stapled or pinned pictures cannot be accepted.</li></ul>	<a href="#">Photo Specifications</a>
Cover Letter	<ul style="list-style-type: none"><li>Original letter with day-to-day travel plan</li><li>If the applicant is submitting the applications of his/her family, then all applications must include a copy of the covering letter</li></ul>	
Travel Insurance	<ul style="list-style-type: none"><li>Covering not less than 30,000 Euros and for the entire stay in Schengen territory</li><li>For applicants applying for a multiple visa - it is sufficient to submit an insurance policy covering the first journey</li></ul>	
Flight tickets	<ul style="list-style-type: none"><li>Onward and Return ticket both</li><li>Should include names of all travelers</li><li><b>If applicable proof of intra-Schengen flight, train itinerary or car rental</b></li></ul>	
Proof of Accommodation	<ul style="list-style-type: none"><li>Confirmation of hotel reservation</li></ul>	
If employed	<ul style="list-style-type: none"><li><b>Employer introduction letter:</b> Original letter on a business letterhead from the employer/company.
